1. RULES

- 1.1 The regatta will be governed by :
The rules such as defined in the Rules of Sailing Race, in particular those of ASOPEN class.
- 1.2 Safety and equipment : each boat will have to be equipped with the mandatory safety material according to the legislation.
- 1.3 The publicity rules of the French Sailing Federation are applicable.
- 1.4 In case of any translation problem, the French text will prevail.

2. ADVERTISING

The event belongs to the advertising C category according to article 20 of ISAF rules as modified by the French Sailing Federation advertising code.

3. ELIGIBILITY AND REGISTRATION

- 3.1 The regatta is open to all 5m70 Open class boats.
- 3.2 The eligible boats can be registered by using the registration form attached to be sent with the requested fees to :

3.3 For a due registration the competitors (each member of the crew) who are living in France have to make available the following documentation :

- valid FFVoile licences with due medical seal and a parental authorization for contestants under the age of 18
- the authorization for publicity
- the tonnage or conformity certificate



3.4 Foreign competitors who do not belong to the French Sailing Federation will have to show proof of a valid third-party insurance with a minimal € 1.5 million coverage.

4 REGISTRATION FEES

The requested fees come to € 130 per boat. They include registration and launching.

6 RACE INSTRUCTIONS

7. PENALTY SYSTEM

Penalty of replacement:

Rules 44.1 and 44.2 are modified so that only one turn, including a tacking and a gibe, is requested.

8 CLASSIFICATION

- 8 1 The a minima Points system of appendix A will be applicable.
- 8 2 The number of races having to be validated in order to constitute a series is 1 :
- 8 3 (A) When at least four races have been validated, the score of a boat in the series will be the total of its scores in all races.
- (b) When 4 to 6 races have been validated, the score of a boat in the series will be the total of its scores in all the races, its worst score being removed.
- (c) When 7 races or more have been validated, the score of a boat in the series is the total of its scores in all the races, its two worst scores being removed.

9 HAULING OUT LIMITATIONS

Any hauling out during the regatta has to comply with the terms of a written authorization given by the Race Committee.

10 RADIO COMMUNICATION

A boat should neither carry out radio transmission once in race nor receive radio communications that would not be receivable by all boats. This restriction also applies to mobile phones.

11 PRIZE

A dedicated ceremony will be organized at the end of the event.

12 RESPONSIBILITY DISCHARGE

The competitors enter the regatta entirely at their own risks (see rule 4 regarding the decision to enter a competition). The organizing authority will take no responsibility for material damage, injury or death, within the framework of the regatta, before, during or after the regatta.

13 INSURANCE

Each competing boat has to show proof of a valid third-party insurance with a minimal € 1.5 million coverage or its equivalent.
